**SAFETY and SITE RULES :**

Must be adhered to. Clan Safety Rules and Regulations (copy enclosed) and Vendor Safety Rules and Regulations, if applicable, apply to all individuals or organizations participating in the Arizona Scottish Gathering & Highland Games.

1. **NO firearms or drugs** are permitted on Hance Park property. Firearms for historic reenactment groups are exempt only with written permission from Hance Park, obtained by the Games Committee.
2. **NO dogs or other animals** are permitted on Hance Park property. Service animals, i.e. guide dogs, are permitted. A copy of animal's training certificate is required.
3. **NO vehicles** are allowed on any field, before, during or after the event, as there is a weight limit. The Games Committee has obtained authorization from Hance Park for motorized carts and special vehicles to transport clan equipment to assigned spaces.

**SPECIAL PROCEDURES :**

1. All Entrants to the facility will have passes that are specified the entire weekend. Two passes will be provided with each reserved space. Additional passes are available at extra cost. If you lose your passes, then you will have to purchase new passes.
2. RV Camping space is available on a limited basis. These are dry spaces with no hookups. The area will be patrolled. Quiet hours are from 11PM to 6AM. RV spaces must be reserved prior to January 15, 2008. After January 15, 2008, reservations will be accepted based on availability. The non-refundable rental fee is \$15 per night payable with the reservation. All camping is at the discretion of Games Committee.

**CITY OF PHOENIX TEMPORARY PRIVILEGE (SALES) TAX LICENSE** Required for all individuals / organizations selling merchandise or services unless said Individual / Organization is an IRS approved tax-exempt non-profit entity. You are responsible for providing proof of your tax-exempt status, upon request. All other individuals/organizations are required to obtain a Temporary Privilege License, collect City of Phoenix Sales tax and complete the special return.
